**Question:** (two-thirds majority passage rate)

Shall there be an increase in the tax levy for a period of three (3) years, from eighty and thirty four hundredths cents (\$.8034) per one hundred dollar (\$100.00) assessed valuation to one dollar and fifty and thirty four hundredths cents (\$1.5034) per one hundred dollars (\$100.00) assessed valuation for general municipal purposes including fire suppression services?

(The proposed tax levy includes a temporary tax levy to purchase fire suppression services from the city of Kansas City, MO. In 2011 the City of Lake Waukomis' general government tax levy of \$.8034 per one hundred dollars (\$100.00) assessed valuation, and a temporary tax levy of \$.70 per one hundred dollars (\$100.00) assessed valuation totaled a combined tax levy of \$1.5034 per one hundred dollar (\$100.00) assessed valuation. The previous three-year temporary tax levy of \$.70 per one hundred dollars (\$100.00) assessed valuation expired in 2011. The proposed temporary tax levy is in the same amount as the previous temporary tax levy of \$.70 per one hundred dollar (\$100.00 assessed valuation.)

To provide funds for the operation, maintenance, improvement, expansion and acquisition of school facilities, including constructing, furnishing and equipping of a new elementary school on existing District property, shall the Board of Education of the Platte County R-III School District be authorized to (a) fully eliminate the reduction in the operating tax levy (Proposition C rollback) for school purposes resulting from sales tax revenues allocated to the District as provided in Section 164.013, RSMo, as amended, and (b) increase the operating tax levy ceiling of the District to \$4.0688 per one hundred dollars of assessed valuation?

If this question is approved, the operating levy of the District is estimated to increase by \$0.60 from \$3.4688 to \$4.0688 per one hundred dollars of assessed valuation.
